QUESTIONS:

- Q4.1: The provided drawings for bidding purposes of the Exterior Elevations is extremely grainy and unclear. Drawing 2 / A2.00 details 12" H Stainless Steel Dimensional lettering (2" Projection Back Lit), but it is unclear what text is on the building. Please clarify what the required copy is on the East Elevation.
- A4.1 Text to read "Malcolm C. Hursey Montessori at the McNair Campus"
- Q4.2 Drawing A10.00 provides a detailed Signage Schedule. Drawing A10.03, A10.04, and A10.05 provides a detailed Signage Plan. The Signage Scheduled and Signage Plans provided for bidding purposes DO NOT align. Please clarify whether we are to bid per the Signage Schedule (A10.00) or the Signage Plans (A10.03, .04, & .05)
- A4.2 Without clearer location on discrepancies, we are providing the following guidance: All discrepancies between the signage schedule and plans will be additive.
- Q4.3 The A10.XX Signage drawing series include Signage Note F related to additional Life Safety Signage (i.e. Pull Station Signage). Although not drawn, specifications 104413 & 104416 clearly identify the Fire Extinguisher identification requirements and we will be leaving that to the supplier of that package. Please provide detailed drawings and quantities required of any additional Life Safety Signage expected to be included in the base bid signage package. (I.e. Fire Alarm Pull Station, etc.)
- A4.3 Contractor should carry standard stock life safety signage for fire extinguishers, fire alarm pulls and other life safety signage as spelled out in the specifications. Numbering will be coordinated with the owner. Refer to life safety plans and engineers' sheets for quantities as required.
- Q4.4 Drawing 9 / A10.02 details White Vinyl room numbers to be applied to the exterior windows as scheduled locations (detailed in the signage schedule and plans). This drawing notes to "Provide 1 sign per door with a door number..." that is not currently scheduled or detailed on the signage plan. Please clarify if a vinyl number if to be applied to all doors, and if so please provide an updated signage schedule / plan reflecting the required mounting locations.
- A4.4 All exterior doorways shall be numbered. The main entry door shall be door number 1 and every exterior door moving clockwise around the building perimeter is numbered sequentially. Only one door needs to be numbered if it is a bank of multiple doors. The vinyl number label shall be fixed to the door in a manner to be easily read from the exterior.
- Q4.5 Specification 101423 section 2.5 A details an aluminum framed "graphic map" to be installed at all "Key Entry Locations". This frame is not scheduled or drawn for bidding purposes. Please clarify if / where / how many of these 27.75" x 17" Aluminum Framed Graphic Map is required for bidding purposes. If required in the project, please clarify if the Owner / Architect is responsible for the graphic design and production of the insert map, or if this is to be provided be the signage vendor.
- A4.5 Contractor to provide 6 graphic maps, locations TBD. Map design will be by the Owner/Architect. GC is responsible for the production and installation.

- Q4.6 Drawing A10.03 details a Sign Type W for Family Restroom 155T, which is not included in the signage drawing set. Please provide a drawing of Sign Type W for bidding purposes.
- A4.6 This should be sign type E, not W.
